

## TERMS AND CONDITIONS

### HSBC Amanah Everyday Global Account-i Fee Waiver Promotion (“Promotion”)

HSBC Amanah Malaysia Berhad (Company No. 807705-X) is referred to as “HSBC Amanah”.

#### PROMOTION PERIOD

1. This Promotion shall commence from 29 July 2019 until 31 December 2019 (for Premier and Advance customers) (“**Promotion Period**”), both dates inclusive.

#### ELIGIBILITY

2. This Campaign is open to all of HSBC Amanah Premier and Advance Everyday Global Visa Debit Cardholders (“**Eligible Cardholder**”).
3. The following categories of persons are EXCLUDED from this Promotion:
  - (a) Non-HSBC Amanah Premier and Advance Everyday Global Visa Debit Cardholders;
  - (b) Non-individual or corporate customers;

8. HSBC Amanah reserves the right to cancel, terminate or suspend this Promotion with 3 days' prior notice. For the avoidance of doubt, cancellation, termination, change or suspension by HSBC Amanah of this Promotion shall not entitle the Eligible Cardholder(s) to any claim or compensation against HSBC Amanah or any and all losses or damage suffered or incurred by the Eligible Cardholder(s) as a direct or indirect result of the act of cancellation, termination or suspension.

HSBC Amanah shall only be liable for any loss or damage suffered or incurred as a direct result of HSBC Amanah's gross negligence and shall not be liable for any other loss or damage of any kind such as loss of income, profits, goodwill or indirect, incidental, exemplary, punitive, consequential or special loss or damage howsoever arising, whether or not HSBC Amanah has been advised of the possibility of such loss or damage.

To the fullest extent permitted by law, HSBC Amanah expressly excludes and disclaims any representations, warranties, or endorsements, express or implied, written or oral, including but not limited to, any warranty of quality, merchantability or fitness for a particular purpose in respect of this Promotion.
11. HSBC Amanah may use any of the following modes to communicate notices in relation to this Promotion to the Eligible Cardholder(s):
  - (a) Individual notice to the Eligible Cardholder(s) (whether by written notice or via electronic means) sent to the Eligible Cardholder(s)' latest address/email address as maintained in HSBC Amanah records;
  - (b) Press advertisements;
  - (c) Notice in the Eligible Cardholder(s)' composite statement(s);
  - (d) Display at its business premises; or
  - (e) Notice on HSBC Amanah's internet website(s) or official social media sites;

where such notices shall be deemed to be effective on and from the 4th day after its delivery publication/display as per the manner described herein. Save and except notices sent via ordinary mail which will be deemed delivered on the 3rd day after posting, notices sent via other modes as described herein are deemed delivered immediately after posting/publication/display.

These Terms & Conditions are in addition to the respective Universal Terms and Conditions ("UTCs") for HSBC Amanah of which the Specific Terms & Conditions for HSBC Amanah Premier and HSBC Amanah Advance, and Specific Terms & Conditions for Retail Banking and Wealth Management are a part of and which regulate the provision of account-i facilities by HSBC Amanah. In the event of inconsistency between these Terms and Conditions and the UTCs, these Terms and Conditions shall prevail in so far as they apply to this Promotion.

14. HSBC Amanah shall not be liable for any default due to any act of God, war, riot, strike, terrorism, epidemic, lockout, industrial action, fire, flood, drought, storm or any event beyond the reasonable control of HSBC Amanah.
